#### **PRESIDENT'S REPORT:**

Have been in contact with CricketWest about conducting an independent tribunal. All documentation about the matter has been issued and confirmation received. Now to wait on advice as to when event can occur.

Attended the Gosnells City Council Club Forum to discuss with the bookings department why the City's clubs are at a disadvantage when booking grounds. Also suggested that the Association consider booking all grounds on behalf of member clubs to avoid outside clubs from booking grounds.

#### **ADMINISTRATOR'S REPORT:**

Clubs advised of potential Jim McKenna and Ian Hale Medal winners – top 10. The trophies ordered and are with Ian for presentation at the Windup.

Locating the average and aggregate winners was a little easier with PlayHQ than it was with MyCricket.

Some clubs requested confirmation of players' qualification for finals.

The new web site is coming along. Taking a lot of time but going well, draft forwarded to committee for information. Looking for a resolution to keep the current page for Prescribed Penalties, Reports, Cautions and Minutes. The only backup we have for all these items is online.

##### **From Peter Anderson**

Club Championship – penalty fines, part of By-Law review.

##### **From Shamez Rashid**

Shamez brought up issue of fines for forfeits. He felt the current amount needs to be reviewed as other clubs face losses in ball fees of 11 players. Higher the amount of fine, then clubs will not easily forfeit games.

There was discussion on this and not all present agreed with an increase in fines. Shamez is welcome to bring to General Meeting for clubs to discuss if he wishes.

##### **From Ian Del Rosso**

SMCA Colts coach paid for the team bus to go to the Colts Gran Final, from Buzzacott to Bassendean and back, Ian proposed that the SMCA pay a portion of the bus cost.

Moved Peter Anderson and seconded Gary Hartman that the SMCA provide \$750 to cover bus costs.

#### **GENERAL BUSINESS:**

Discussion on Kookaburra balls splitting, to be considered further.

Steve Kemp believed there should be a trial on Kookaburra Crown balls to ascertain their viability in a One-Day grade match. This to be considered for next season with the Association proving 8 balls to be used in a round and then balls then to be returned to the SMCA for inspection.

Mario felt that names of persons found not guilty of an offence should be removed from the web site P&D report. Gary advised that this was the only archive history we have of the hearing.

Match finished in one-day matches once a result is achieved to be added to all grades be discussed at the General Meeting.

Joe Covic discussed if two forfeits in the same grade then the two teams missing out in a match play each other. This would be by agreement of both clubs. To be considered further.

Needs to be further discussion on women's cricket within the SMCA, perhaps a meeting soon with Sabrina Del Rosso in attendance.
