## TREASURERS REPORT:

Still received nothing from Kookaburra (\$2850). Still owed \$1000 by Capture Sport. Monies from Cricket West was received this past week.

Fines for the season will be around \$3760 – compared to \$3400 last season.

#### **UMPIRE'S ADVISOR:**

Steve Nichols advised that this season we had 12 new umpires. Lost 4 during the season, 3 in the last 2 rounds.

Had 24 umpires on the semi final weekend. 5 games with only 1 umpire.

Umpires windup will be on Wednesday 16th March.

It was agreed that it had been a tough start to the season for the umpires but Steve Nichols had done a great job and all appeared to be going well.

## **PROTESTS AND DISPUTES:**

Evans was suspended forthwith from all cricket matches under the auspices of the SMCA until the completion of the 2011/12 cricket season. SJ Blues CC is to be fined \$100. This suspension is recognised by all cricket associations in Western Australia and the details will be forwarded to the WACA for distribution to all associations.

15-02-2011 Paul Ledingham, Thornlie pleaded not guilty to initiating contact with A. Evans of SJ Blues. Found not guilty.
