Report:	Charge Abuse by Pavan Ganti and Jatinder Gill towards opposition batsman. 22nd February 2025, ODF Round 16
Notes:	As the player was overseas the P&D allowed the hearing to be done by email. Statements were received by the following: Jatinder Gill Amit Singla - Captain Brendan Fowler - President A screenshot of a WhatsApp message sent from the Champion Lakes Cricket Club One Day F Captain to Canning Vale asking them to umpire against the spirit of the game against another club. All other statements we went through at the last P&D. From Statements Jason Patton said he did warn the batsman for telling them to

	<p>go fetch the ball and accepted the apology. Jason did indicate words were exchanged between both teams but not too aggressively but stated he did not understand the language. Both statements from Jatinder Gill and Amit Singla admit that there was an exchange between the batsman and bowler Pavan Ganti in Tamil. Both Jatinder and Amit claim that Jatinder does not speak Tamil and knows little Hindi. Jatinder's statement and the receipt of the WhatsApp screenshot now put a cloud over the evidence of the Champion Lakes Captain. Brendan Fowler the president gives a glowing reference as to his commitment to the club. We believe that Jatinder Gill's involvement would have been minor and would have probably not resulted penalty which ironically he has served a penalty by not being at the P&amp;D as he went overseas before being issued with the notification. Under By-Law 63.b that if a person reported under these rules is unwilling or unable to attend a board hearing on a specified date or fails to tender written evidence in the form of a Statutory Declaration, that player will be automatically suspended until such time as the board be next convened to hear a case. This was applied at the P&amp;D held 26th February 2025. Jatinder has supplied a statement which is not a Statutory Declaration as he is unable to as he is overseas. The P&amp;D moved to try to resolve this case on the grounds that the P&amp;D accepted a statement on 5th March 2025 from a player who was not in attendance which was not a Statutory Declaration. The P&amp;D decided to issue a caution to Jatinder for his role in the incident.</p>
<p>Penalty:</p>	<p><b>Jatinder Gill has been issued with a caution</b> for his role in the incident and this stays in place for 12 months and if he receives a caution, prescribed penalty or P&amp;D suspension in that time 4 playing days will be added to the penalty. Jatinder is free to play immediately.</p>
