### Report:

### Tribunal Notes:

SK asked BSS how he pleaded to each offence and what his version of events were:

BSS advised that the umpire was not in the correct position to adjudge whether he was run out. He questioned the umpire for between 5 to 6 seconds and stated that the umpire advised his bat was in the air and not grounded. BSS admitted to frustrated by the decision and suggested that the bowler (and Thornlie captain) had said he was not out. BSS then stated that the phrases 'f\*\*\*\*\* dumb' and 'f\*\*\* off' were directed to his batting partner for not taking the run that was there.

BSS denies taking off his helmet and throwing his bat, suggesting that he threw his bat in the air and it landed on his foot. Denies throwing his bat at any time.

BSS advised that he apologised to the umpire for his actions.

PA then read out the umpire's statement with which BSS denies all comments made by the umpire.

BSS and his advocate were then asked to leave the room.

The panel then requested that the witness of the events then enter the room. SK then asked for his version of events, of which his comments supported the detail provided by the umpire in terms of BSS's body language towards the umpire and equipment abuse. He was unable to provide comment on any language that may have been used.

The witness was thanked and then left the room.

BSS and his advocate were then asked to re-enter the room to be advised out outcome

Penalty:

Level 1 – Equipment abuse; guilty (2 playing dates)

Level 1 – Dissent; guilty (caution)

Level 2 – Intimidating an umpire and Disrespecting an SMCA Official; guilty (10 playing dates)

BSS is suspended for eight (8) playing dates with an additional four (4) playing dates suspended for two (2) years. BSS is unavailable for selection until December 13.

Kelmscott is also fined \$100 based on the outcome of the Level 2 offence.
